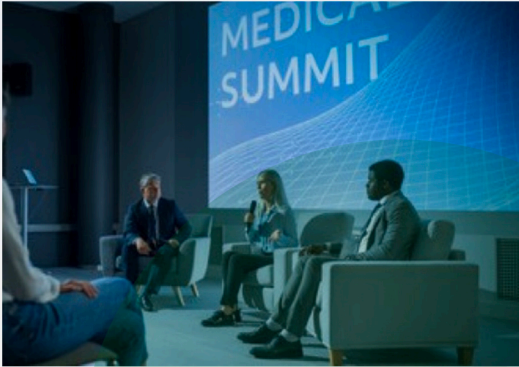


# OBJECTIVES OF THE FORUM
