TRADE AND NUTRITION IN ARAB COUNTRIES



Arab countries are among the world's leading net food importers. This reliance on food imports is largely due to low agricultural productivity, which stems from several challenges, including limited water resources, recurrent droughts caused by harsh climatic conditions, and insufficient arable land.

In this regard, trade plays a crucial role in supplying local markets and ensuring food security and nutrition in the region's countries. Estimates indicate that the share of imports in consumption could reach 64.7 percent by 2031, highlighting the low levels of self-sufficiency for most commodities and the significant dependence of these countries on imports.

The vulnerability of markets in the Near East and North Africa region has increased due to recent trade challenges, particularly those arising from the COVID-19 pandemic and global geopolitical tensions.

To better understand the challenges of supplying markets in this region in light of food security objectives, the Food and Agriculture Organization of the United Nations (FAO) Office for the Near East and North Africa Region (RNE) and the Islamic Centre for Development of Trade (ICDT) are organizing a regional webinar on 8 May 2025 at 14.00 (Cairo Time) the 2024 The State of Agricultural Commodity Markets and the Evolution of global agrifood trade and trade policy and implications for nutrition with a focus on Arab countries.

OBJECTIVES

This seminar aims to:

- examine the role of trade in supplying the Near East and North Africa region with food and micronutrients, highlighting its potential to enhance dietary diversity and improve nutritional outcomes;
- → present aspects of import dependency and vulnerability to shocks in the countries of the Near East and North Africa region;
- → present examples of trade policy measures that can support nutritional objectives in this region. (For example, lowering trade barriers for nutritious foods, implementing labeling system, and introducing taxes on unhealthy products); and
- explore ways to strengthen value chains' resilience to trade shocks in the region and discuss the role that regional organizations can play.
